VEHICLE ENTRY FORM

PLEASE READ THE FOLLOWING PRIOR TO COMPLETING REQUIRED FIELDS. A NUMBER OF AMENDMENTS TO CONDITIONS OF ENTRY HAVE BEEN IMPLEMENTED.

- 1. All applications for entry must be received no later than 31 July 2025.
- 2. Entrants must be on site no later than **09:30** each day. The first four vehicle occupants, (including the driver) are entitled to free entry, all subsequent passengers will be required to pay the full admission price.
- 3. Occupants of any vehicle which arrives having not completed the application process will be charged the full admission price and may be refused entry.
- 4. Entrants must ensure that all drivers are lawfully qualified to drive the vehicle.
- 5. Entrants must ensure that the vehicle is appropriately insured against third party risks for road use. Additionally, vehicles operating free bus services, internal or external, must be insured for that purpose. The vehicle must have valid road tax, and MOT where applicable.
- 6. Entries must be in a clean, complete and safe condition.
- 7. Running on trade plates is not permitted.
- 8. A speed limit of **10 m.p.h**. shall apply in all areas of the museum site.
- 9. Unattended vehicles must be securely braked, with the engine off.
- 10. Drivers must pay full regard to marshals' instructions and conduct themselves in a manner which will not inconvenience other road users or cause annoyance to other persons at any time.
- 11. No unassisted reversing is permitted on site.

12. Excluding allocated internal or external free bus service journeys, no vehicle movement is permitted on site prior to final departure.
